#### **New Business**

#### **Application 16-01**

Shawn M. and Alison E. Lawler, 591 Morse Road, Mason NH 03048. Lot line adjustment between lots L-50, L-51 and L-59 at 591 Morse Road, Mason NH (totaling 16.137 acres) and subdivision of lot L-59 into 2 parcels. The result will be 4 lots: L-50 (4.057 acres), L-51 (4.020 acres), L-59 (4.007) acres and L-59-1 (4.004 acres).

Shawn Lawler presented the plan. The board reviewed the plat. Observed:

The legend does not show the double line used to denote culvert crossings.

Mark made a motion to declare the application Complete. Eric seconded. Vote: All in favor.

Mark opened the hearing for pubic comment. The board observed that the following actions are needed:

- Set granite bounds at all lot corners along the Class V roads.
- · Add the culvert crossing symbol to the legend.

Mark made a motion to grant conditional approval to Application 16-01, subject to the following conditions:

- Set granite bounds at all lot corners along the Class V roads.
- Add the culvert crossing symbol to the legend.
- Pay the remaining fees:
  - Application fee, mailing and postage are already paid (\$382.50).
  - NRPC consulting fee, filing fee, LCHIP, and any other fees are outstanding.

Conditions must be met by December 1, 2016.
