Notice is hereby given in accordance with RSA 676:4 that the following application(s) will be reviewed for completeness by the Planning Board on July 31, 2019 at the Mann House located at 16 Darling Hill Road during a regular meeting:

7:40 P.M. MAS 19-03: An application by David Farwell, 37 Mason Road, Brookline, NH 03033, for the lot line adjustment of the common lot line between Lots H-39 and H-40. The proposed lot line adjustment will transfer 1.245 acres from Lot H-40 (currently 13.057 acres) to Lot H-39 (currently 2.781 acres), resulting in Lot H-39 becoming 4.026 acres and Lot H-40 becoming 11.812 acres. Frontage for each lot remains unchanged. Both lots are

in the GRAF district and lie outside of the 100-year flood hazard boundary.

If the Board deems an application as complete, a public hearing may immediately follow. The public hearing will be continued to a date certain until an application is approved or disapproved. This serves as notice for any continuation of the public hearing to a date certain. The Planning Board meets the last Wednesday of the month at 7:30 PM.
