- \*JLCE- First Aid and Emergency Medical Care- remove 8<sup>th</sup> paragraph beginning with “The District makes it possible”, keep “The District does not provide student accident insurance”.
- \*JLCF- Wellness Policy- second paragraph replace “will” with “may”.
- \* JLIA- Supervision of Students- Add “guardian” where parent is noted in policy.
