- A motorcycle group that researches Class VI roads and then distributes maps scheduled a very large "Adventure Ride" that includes the Class VI portion of Scripps Lane. Chief is not aware of any complaints and expects to see more activity in the future.
- Chief is working with the State Police to increase network communication. Various ways to increase communication to dispatch are also being reviewed.

- Chief discussed the Police Department's efforts to patrol and monitor speed through the center of town. Chief states there have been a total of 35 hours of patrol with no concerns at this time. Selectmen have been looking into the possibility of changing the speed limit in the center of town to 25mph, though given the amount of patrol recently done with no concerns, the Selectmen elect to hold off on further action at this time.
- Dave Morrison and Richard Stockdale form the Mason Energy Commission discussed their current findings regarding electric vehicle facts and the potential impact on Mason.
